



POOL MEMBERSHIP AGREEMENT

We invite you to make an application for membership for Pool Membership at Ashley Plantation Country Club and in connection therewith, agree to the following:

POOL MEMBERSHIP AGREEMENT

General terms, conditions, and benefits applicable to all pool memberships.

1. The pool Member shall abide by any and all of the rules, regulations, and policies promulgated by the Club. The Club reserves the right on occasion and at any time, with or without notice, to change, modify, amend or vacate its fees, rules and regulations and policies.
2. You agree to abide by any and all of the rules, regulations, and policies promulgated by the Club. The Club reserves the right, on occasion and at any time, with or without notice, to change, modify, amend or vacate its fees, rules and regulations and policies.
3. Each pool Member shall always register at the pool entrance upon entering the facility.
4. Pool members are allowed to utilize the pool facilities at all times that the facility is open during the "Pool Season", subject to the provisions of the club rules and regulations. Club-sponsored events take precedence over a Pool Member's right to utilize the pool facility.
5. Membership in the "Ashley Plantation Stingrays Swim Team" is not included in your pool membership. Pool Members acknowledge that they understand that the aforementioned swim team is a separate entity from Ashley Plantation Country Club.
6. Pool members have access to the food and beverage cabana at the swim club. However, charging privileges are not a part of the "Pool Membership", only Golf and Social Members of the club enjoy account charging privileges.
7. "Social Events" conducted by Ashley Plantation Country Club may from time-to-time take place at the pool facility. Such events are considered private and only available to golf and social members of the club.
8. Pool members acknowledge that outside food and beverage is not permitted within the pool facility.
9. The pool member fees are non-refundable and non-transferable. The pool membership will be effective from Saturday, May 27, 2017 through Monday, September 4, 2017. Ashley Plantation Country Club Management may, at its discretion adjust the opening or closing date for the season.
10. Pool memberships may be suspended or revoked for non-payment or for failure to abide by any of the rules, regulations, and policies of the club. The pool membership may be recalled at any time at the discretion of Ashley Plantation Country Club Management. In such case, if annual dues were paid they would be refunded on a pro-rata basis for the remaining months of the membership.
11. Pool Members are allowed to bring guests at the published guest fee rates. (\$8 per guest, per day) All guests must be accompanied by a member unless special arrangements have been made with the General Manager or Pool Supervisor. The Club is not responsible for any loss or damage to any of the Pool Member's or Guest's property used or stored at the club or brought upon club property and the Pool Member shall look solely to the Pool Member's insurance policies for any claim for loss or damage. The Pool Member / Guest hereby releases the Club from any and all causes of action, claims, and liability with respect to any loss or damage to any of the Pool Member's / Guest's property used or stored at the Club or brought upon the property of the club.
12. Pool members shall refrain from entering the golf clubhouse in swim attire.
13. All children under twelve (12) years of age must be accompanied by a parent or guardian at all times.
14. The pool membership must be paid in full prior to the opening date of the season unless other arrangements have been made with the General Manager.
15. If membership is terminated before completion of the season, I understand I am responsible for the entire balance of the membership for said season.

THIS AGREEMENT AND REFERENCED RULES, REGULATIONS AND POLICIES CONSTITUTES THE ENTIRE AGREEMENT BETWEEN THE PARTIES. ANY CAUSE OF ACTION BY ANY PARTY TO THIS AGREEMENT WILL BE GOVERNED BY THE LAWS OF THE COMMONWEALTH OF VIRGINIA.
